

SECURITY MEASURES FOR AIR CARGO AND SHIPPER SECURITY DECLARATION

AVIATION SECURITY AIR CARGO REGULAR CUSTOMERS

This document is prepared by Royale International Couriers Pty Ltd in conjunction with the guidelines set down by the Aviation Transport Security Act 2004 and the Aviation Transport Security Regulations 2005. These regulations require that all air cargo be subject to security controls prior to dispatch. These controls are intended to prevent the placement of explosives or incendiary devices in aircrafts. Security controls are applied by Regulated Air Cargo Agents. Royale International Pty Ltd is a Regulated Air Cargo Agent.

1. As a regular customer of Royale International Pty Ltd, being a Regulated Air Cargo Agent, you are entitled to expedited dispatch arrangements for consignments received by Royale International Pty Ltd on your behalf.
2. To take advantage of this status, you are responsible to ensure that your consignments are prepared and handled in a manner, which will not compromise their security standing.
3. To ensure that your consignments are not delayed, you may care to note that we cannot expedite the dispatch of consignments:
 - a. With damaged or insecure packaging or where it is evident that the original packaging of a consignment may have been subject to tampering or interference;
 - b. Where it cannot be verified that the person presenting the consignment is a bona fide representative of the regular customer; and
 - c. Where it is not clear from the documentation that you are the owner or originator of the items contained in the consignment.

All shipments sent by you through the Royale International Pty Ltd system will be required to be security cleared. It is your responsibility as a "Regular Customer" to ensure that shipments sent on your behalf are subject to proper security scrutiny.
